

MINUTES OF THE MONTHLY MEETING OF LIMPSFIELD PARISH COUNCIL HELD ON MONDAY 10TH MARCH 2025, 7PM AT OXTED LIBRARY

Michael Tinker gives brief introduction to himself (He has already met 4 of the councillors in person).

Proposed by: Thomas Briggs Seconded by: John Thompson. All present (6) in favour. (AO and BdH not present at this point)

Michael Tinker is duly co-opted as parish councillor, effective immediately.

- 6. COUNCILLORS' REPORTS (Surrey CC & Tandridge DC)

Claire Blackwell

- Devolution: Initial plan from Surrey County Council and the District and Borough councils is due for submission on 21st March and final plan 9th May. Nothing more to report now.
- JT asks about housing supply figures, which are very high. CB says TDC will have to try to get this reduced, but it will be difficult.
- "Grey Belt" will be a big issue for villages in the green belt. Green Belt assessments will be undertaken across the district.
- AT asks about number of planning application decisions made by officers, vs those
 that go to the TDC Planning Committee. CB says very few applications are called in
 to Committee the vast majority are determined by the delegated officer powers.
 There will shortly be another white paper that will outline powers of Planning
 Committees (District).

7. CHAIRMAN'S NOTE(s)

- 7.1. Newsletter last call for entries. TB to provide introduction to include reference to devolution.
- 7.2. TB raises CIL money and it's worth thinking about any projects. Applications from 1 May.

- 8. FINANCE & GOVERNANCE Cllr Antony Taylor/Clerk
 - 8.1. Note of end of February 2025 balances Current balances £84,291
 - 8.2. March expenditure items for approval/to note
 - 8.3. Budget proposals and grant requests:
 - 8.3.1. CAB general grant. CAB has requested a sum of £1000. This is felt to be too high for LPC to contribute. MW proposes £500. JW seconds. 4 for, 4 Against, 1 abstention Chair has casting vote (against) TB proposes £350 AT seconds. 5 for, 4 against.
 - 8.3.2. Air Ambulance KSSAS (Kent, Surrey, Sussex). Request for £500. We have donated in the past (around £300). MW proposes, TB seconds. All in favour.

- 8.3.3. First Responders defibrillator maintenance £140 AT proposes, MW seconds. All in favour.
- 8.3.4. Chart Fair support £375 to cover administration and support AO proposes TB seconds. All in favour.
- 8.3.5. Limpsfield in Bloom grant AO gives overview of final does not vote due to disclosable interest. TB / BdH. JW abstains due to issue with mowing of the Glebe Field (see below*). Everyone else in favour (7). AO says that this will be the last year that LIB will enter, after 20 years of taking part in the RHS Villages in Bloom, but the group will continue in the village in a less formal capacity.
- 8.3.6. LW / Brook Field footpath maintenance / aggregate AO £395.01 AO proposes, MW seconds. All approved.

*The Glebe Field, Detillens Lane. JW raises the issue of the mechanical mowing of the Glebe Field which she believes conflicts with our efforts of biodiversity. Roger Oldfield (resident of Detillens Lane) is gathering agreement and contributions for this from residents of The Glebe Field. Ann does not agree it is in conflict. Claire Blackwell notes that wildflower meadows should be mown once a year in the autumn.

Roger Oldfield is apparently instigating the first mow on Wednesday 12th March. It is not clear on whose authority the residents are mowing the field. It is a designated local green space (designated by the Parish Council for the LNP). It is owned by the Diocese and no longer tenanted by Amanda Skinner for her cattle. Some of the residents believe that mowing the field makes it less open to development, MW and JW believe this is quite the opposite and very inappropriate. They believe the residents should have approached the Parish Council due to its LGS designation and do not have the authority to act on behalf of the parish in this matter.

- 9.5.3. Whinchat Cottage Hookwood MW has reported the rubbish dump to TDC to Environmental Health / Enforcement. It is believed that rubbish is being dumped there by the owner, that is not from the property. CB to follow up.

- 11.1. Working Group Update round table meeting on 4th February was very well attended with lots of positive updates and suggestions. AO has circulated a revised draft plan awaiting comments and suggestions to bring to the next meeting.
- 11.2. TB raises issue of deer culling and deer over-population on the common/Chart, with view to road safety and disease also problem with land/vegetation. MT says it is an issue on his land. Clerk notes that the local farmers have also raised the issue in the past (particularly since covid with halt in culling and fragmentation of the Common /Chart areas).

AO to ask NT their views on this.
