

## Minutes of the Limpsfield Parish Council Planning Committee held on Tuesday 27 May 2025 at 6PM – Parish Office of St Peters, Limpsfield

1. APOLOGIES FOR ABSENCE - Ted Beresford Knox

2. DECLARATIONS OF DISCLOSABLE INTEREST

Jenny Williams regarding potential application by public attendee, Roger Sparkes. Jenny consults with White & Sons who deal with Roger Sparkes' developments.

3. PUBLIC SESSION -

Jenny Williams absences herself from this part of the meeting.

Roger Sparkes (developer) and Ron Fender (architect) representing Merlin Real Estate (and Roger's two children) attended to talk about potential residential development plans in the fields below St Michaels/Thornhill bordering the A25.

Roger gives a brief overview (with associated plans/drawings) of the development ideas – which have not been submitted for planning application yet. He and Ron are scheduled for a pre-planning discussion with TDC.

Roger notes that while he could go for a large-scale development, he prefers to propose a smaller development, more in keeping with the surrounding area and the needs of the Limpsfield community, and that he hopes will be acceptable to local residents, and particularly attractive to those Limpsfield residents wishing to downsize.

He is hoping to build a small development on the lower fields below Thornhill, consisting of nine single storey units of two-three bedrooms with landscaped communal gardens.

Roger and Ron are both intending on living in the development themselves.

An additional development of 15 apartments is planned for a field adjacent to St Michaels, also one or possibly 2 houses on the small area of land (Owned by his Son Desmond and Daughter Michelle) behind the existing house on the A25

Mark Wilson notes that the LPC would have no decision-making on whether TDC decides this land is suitable for development and stresses that this area is Green Belt and will be adjacent to the proposed extended area of the Surrey Hills National Landscape.

The councillors agree that while these sites may not be eligible for development, depending on TDC's view, if they were, this sort of development consisting of smaller dwellings would be more in line with the Limpsfield Neighbourhood Plan.

<u>Next steps</u> – developers will have pre-application meeting with the officers.

LPC will await any formal planning application.
