IT IS SPECIFICALLY TARGETED AT LOCAL RESIDENTS, BRINGING TOGETHER PEOPLE OF ALL AGES FOR AN ANFTERNOON OF TRADITIONAL VILLAGE FUN. IT FOSTERS COMMUNITY SPIRIT. WE RAISE FUNDS THAT CAN BE USED TO SUPPORT COMMUNITY PROJECTS, INCLUDING THE WEEKLY COMMUNITY COFFEE MORNINGS THE RESIDENTS ASSOCIATION WAS FORMED IN JANUARY BASED ON THE CHART FAIR COMMITTEE. IT PROVIDES A FUNCTION THE COMMUNITY MAY NEED IN A VARIETY OF CIRCUMSTANCES AND AS IT IS NOT A STATUTORY BODY CAN ACT IN DIFFERENT AND COMPLEMENTARY WAYS TO LPC TO SUPPORT THE COMMUNITY. OUR FOCUS IS COMMUNITY EVENTS, FOSTERING COMMUNITY SPIRIT AND SUPPORTING AND ENHANCING THE CHARACTER OF THE VILLAGE.

(if yes, please provide amount and funder(s) details)</p>	<p>IN THE PAST WE BELIEVED WE WERE ABLE TO BENEFIT FROM THE INSURANCE OF LPC FOR THE FAIR AS A SUB-COMMITTEE – IN 2025 WE DISCOVERED THAT THIS WAS NO LONGER POSSIBLE. LPC KINDLY PROVIDED A CONTRIBUTION TO THE COST OF SECURING OUR OWN POLICY IN 2025</p> <p>THE REMAINING COSTS OF RUNNING THE RESIDENTS ASSOCIATION AND THE FAIR ARE ALL FUNDED BY FUNDS RAISED FROM PRIOR YEAR FAIRS AS WELL AS FROM THE CURRENT FAIR. THESE OTHER COSTS EXCEED £1,000 PER YEAR AND INCLUDE ITEMS RANGING FROM ANNUAL FAIR COSTS SUCH AS OUR EVENT LICENSE AND PRIZES TO OTHER ADMINISTRATIVE COSTS SUCH AS WEB HOSTING. THIS EXCLUDES RECOGNISING DONATIONS OF PRIZES FOR OUR RAFFLE WHICH WOULD HAVE AN ANNUAL VALUE IN EXCESS OF £500 ON TOP OF THE ABOVE.</p> <p>WE RECEIVE A MIX OF DONATIONS AND RAISE FURTHER FUNDS FROM OUR STALLS AND GAMES WITH OUR PRIZE DRAW BEING A KEY ELEMENT OF OUR FUNDRAISING.</p> <p>AS YOU CAN SEE THIS MEANS THAT >£1,500 OF FUNDING AND DONATIONS IS PROVIDED FROM OTHER SOURCES IN ADDITION TO US SEEKING £500 FROM LPC.</p>
